Overview

What is the California EL Civics Exchange?

- Repository for original EL Civics instructional materials created by California WIOA, Title II: AEFLA/EL Civics agencies
- A joint project between CASAS and OTAN, funded by the California Department of Education

Why do we need a California EL Civics Exchange?

- Requested by California agencies
 - Collaboration between CASAS and OTAN facilitated the development
 - Funded by the California Department of Education
- Quality Instructional Materials
 - Materials evaluated for quality content and accessibility
 - Serve as a model of excellent materials in developing their own materials
 - Assist agencies in offering varied EL Civics instruction

What was the Development Process?

- CASAS and OTAN met to discuss project in 2018-19
- Requested CDE Funding in 2019-20 and continued to meet
- Received funding for 2020-21 and began the development process:
 - Content
 - Technology
- Field Testing began in April 2021
 - Content review
 - Accessibility Review
- Website Opening **July 1, 2021**
 - elcivics.otan.us

What kinds of materials are included?

- Instructional materials which:
 - teach EL Civics content to English language learners
 - are part of the 30 hours of instruction required in California before administering an EL Civics Assessment (COAAP)
 - Since COAAP Assessments are high stakes, they may not be accessed or submitted on the website.
 - are licensed by Creative Commons nomenclature
 - allow use of the materials according to the Creative Commons requirements
 - are accessible according to Section 508 of the Rehabilitation Act (amended 1998) and Web Content Accessibility Guidelines (WCAG) 2.1 recommendations

What is the review process?

- Two stage process
- Materials are reviewed for:
 - Content - CASAS
 - Quality of presentation and practice materials
 - Teach the content of the COAAP
 - Creative Commons licensing
 - Technology - OTAN
 - Accessibility

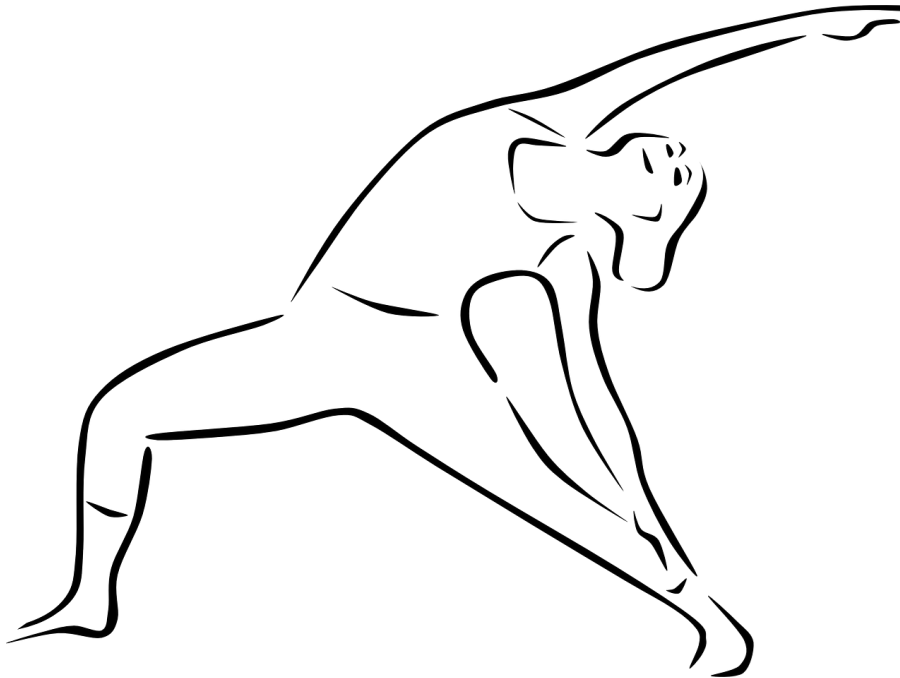

 - Document format (.doc, .docx, .pdf, .jpeg, .png)
 - Rubric criteria
 - Accessibility
 - Creative Commons licensing

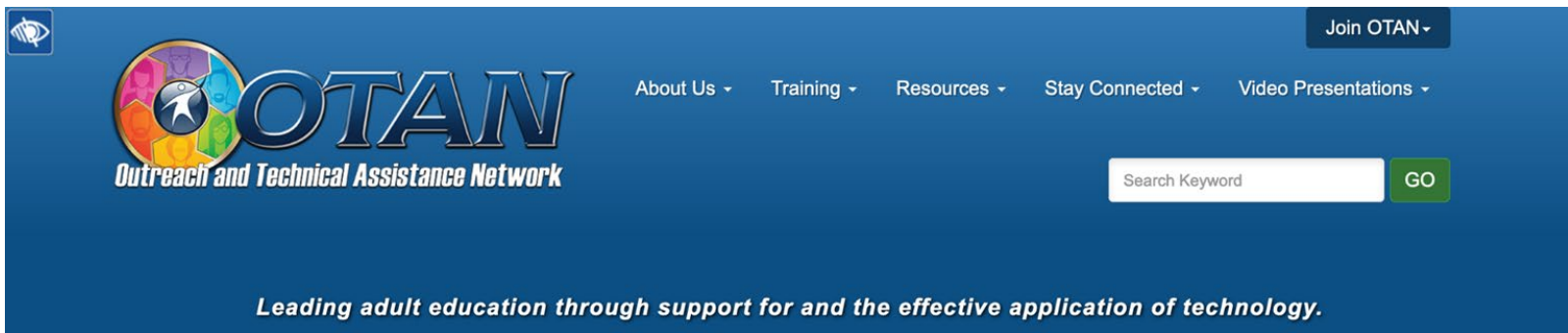

What is Creative Commons licensing?

What is the attribution for the ELC materials?



What is Creative Commons licensing?

- openly licensed creativity
- a body of work freely available for legal use, sharing, repurposing, and remixing
- a standardized way to grant the public permission

How can I apply the license?

You must own or control copyright in the work.

This can be as simple as a bit of text stating and linking to the license in a copyright notice, like this: © 2019. *This work is licensed under a [CC BY 4.0 license](#).*

What is the attribution needed for ELC materials?



CC BY-NC-SA: This license allows reusers to distribute, remix, adapt, and build upon the material in any medium or format for noncommercial purposes only, and only so long as attribution is given to the creator. If you remix, adapt, or build upon the material, you must license the modified material under identical terms.

CC BY_NC_SA includes the following elements:

- BY - Credit must be given to the creator
- NC - Only noncommercial uses of the work are permitted
- SA - Adaptations must be shared under the same terms

As works are recognized, creations should be licensed so other teachers and users know exactly how and for whom they were intended to be used.

August 13th 1-2pm: [Creating Accessible Documents](#)

As we experience more and more technology in our lives, we recognize how much it can help all of us to achieve more, be more productive and more creative. But sometimes we overlook the fact that these same technologies can help our learners who have physical disabilities to experience these same benefits. 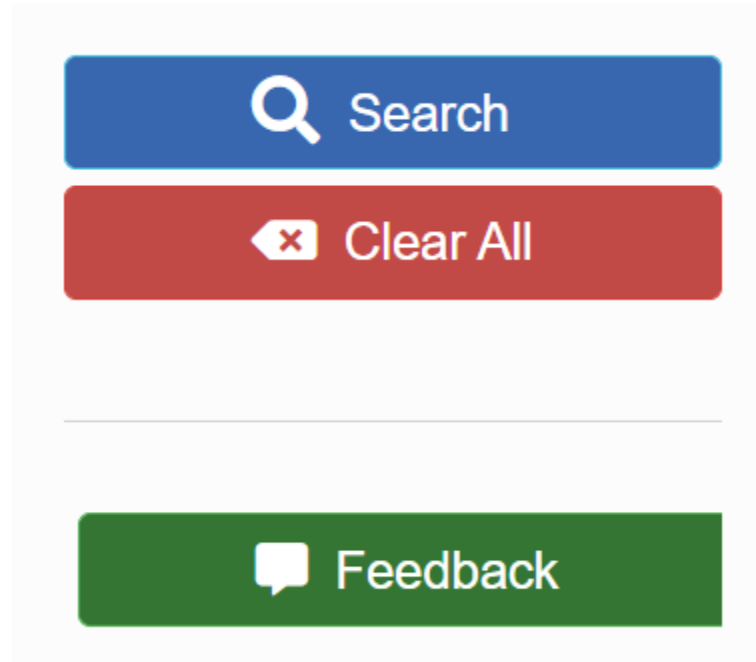
